PRINCIPALS REPORTS

OV-Mr. Cline

Back to School Night had a turnout of 375 and there were 220 backpacks distributed at this event. Clubs began today; all 362 club openings filled. Some clubs are free, others required a fee. Registration will reopen in the Spring. Open house is next Monday from 2-3:15pm. Child Abuse and Neglect online training is ongoing and the Spanish version is available on its website. This is required to go on field trips and volunteer within the school. The certificate needs to be printed and brought to the office. New at OV, the Lunch Buddy Program where volunteers from a local church come to help kids with reading during lunch. This however, does not affect students recess time.

The most recent volunteer training had 12 parents last week. Open House is also next Monday from 8:30-10:30am which includes a short meeting followed by classroom visits of parents. Also, there was a fantastic turnout of 45 parents at our 1st monthly Principals Coffee. Celebrating recognition of excellent reading performance of African Americans and Hispanics at NHE was mentioned and NHE ranked within the top 5 and top 2 of all 133-elementary schools in Montgomery County.

TREASURER'S REPORT—ERIN

- \$4120 in gift cards is slowly being shared with the fire victims to get items that they need.
- \$9665 is in the fire victims relief fund. Staff are working with Parent Outreach Coordinators and Linkages to Learning to get those funds to the families who need it.
- OV—BTSN sold \$6600 worth of items at the book fair. In total, we returned \$14,400 back to the book fair sponsor. OV made \$2000 for their school from this book fair.
- There are 2 requests from OV to amend the current budget:
 - 1. Spirit Wear process run thru the PTA, we currently do not have it on our budget and it's once a school year.
 - 2. Student Store is ran once a week by 2 teachers that have been appointed to support the school store hours. Proceeds go to the school funding for student recognitions. PTA asked to do a once a month deposit to replenish school store with supplies needed.
